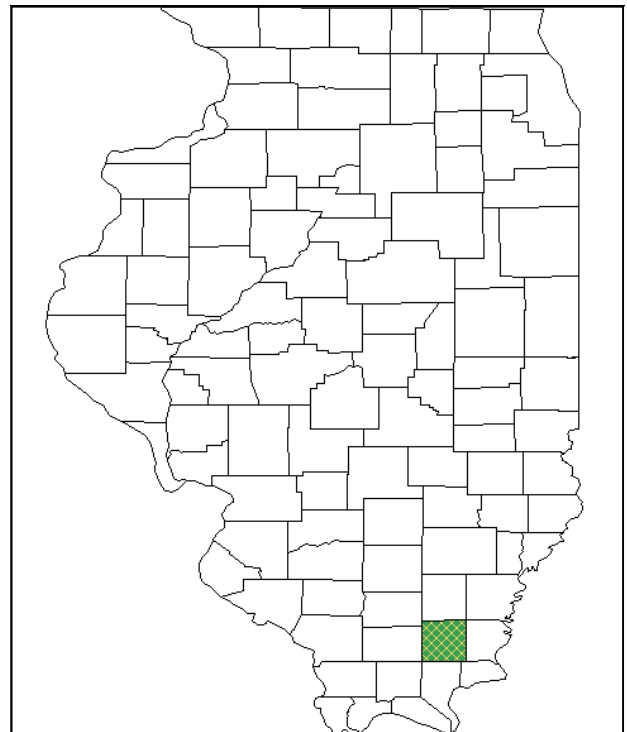

Saline County:

Saline County was formed from Gallatin County in 1847. It was named for the Saline River and springs from which salt was produced in the county. The county is known as the gateway to the Shawnee National Forest and Garden of the Gods Country.

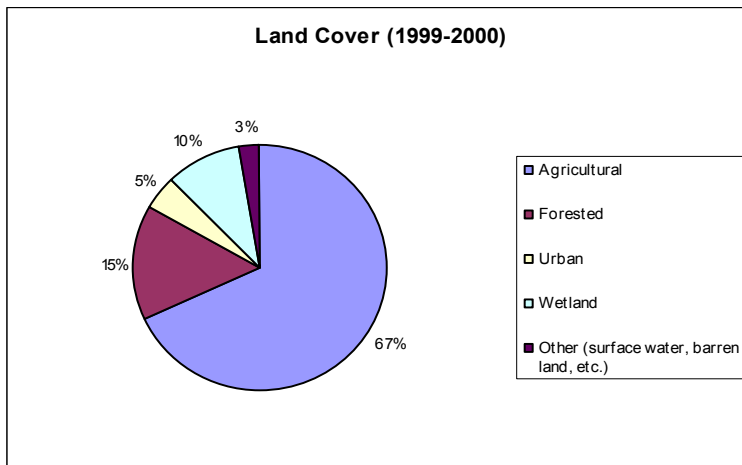

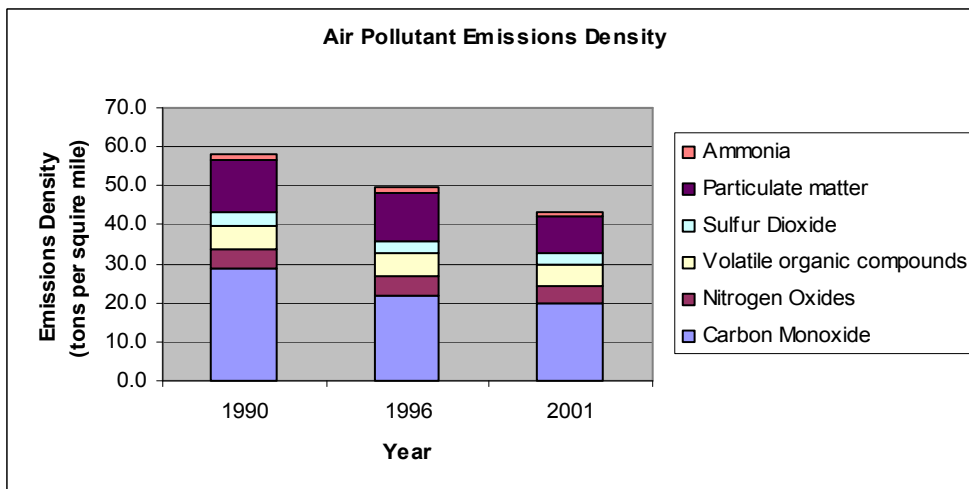

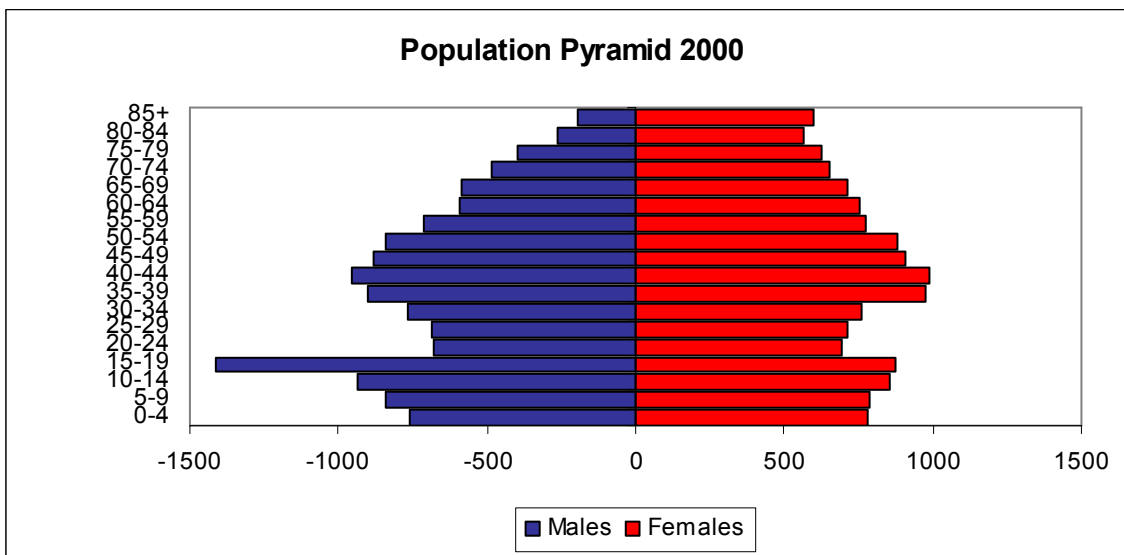

Note: This table shows that between 2002 and 2003, there were -22 net migrants to Saline County. The incomes of the in-migrants was higher than that of the out-migrants. The overall net migration is very small relative to the gross migration, which may bear more investigation. More migration movement occurred between Saline and counties outside of Illinois than with other Illinois counties. Net migration to both Williamson and Gallatin Counties was small but negative.

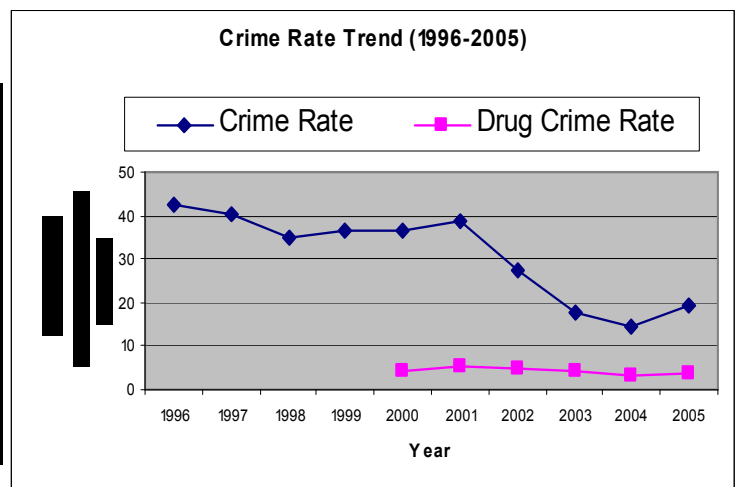
